

PRICES

For French customers : you will have to pay with taxes.

For EU customers : We will apply the intracommunity invoicing, according to the VAT system of autoliquidation by buyer. You will receive a VAT free invoice.

For non EU customers : You will receive a VAT free invoice, and have to pay the VAT in your own country, declaring it to your tax administrtion.



GLASS RENTAL PACKAGES

We offer two packages in this order form, here is some additional information :

- « SERENITY » package : If the dirty baskets of the day before weren't given back at the end of the day, the clean baskets won't be delivered next morning. You will have to put the baskets on your stand (or next to it) every evening, visible, in order to make our work easier.

- « FREEDOM »: You will have to give the glasses back at the end of the fair, on the last day. Even if you choose this package, you can have access to occasional extra washings. They will be charged 14€ without taxes per washing.

ORDER

Please submit orders as soon as possible in order to be sure to have everything you need.

For the « SERENITY » package, we suggest to order as much baskets as you can stock in your stand in order to avoid waiting time and comings and goings.

The « SERENITY » package includes one rewashing per day of your whole stock. Orders must be paid before the exhibition or they won't be taken into account.

CANCELLATION CLAUSE

After the 29/04/19, any cancelled order won't be refunded.

DURING THE EXHITION

You have to call our staff when you want to wash your glasses. Non-included washings are possible after payment by credit card or cash.

A checking will be done with you to list the potential missing or broken articles everytime we exchange a basket. The payment of these will be done directly.

INVOICING

By convinience, the invoice has to be paid before the exhibition by bank transfer or by check. The payment of additional washings will be paid directly onsite.

LIABILITIES

Customers are responsible for the glasses they rent. A checking will be done by our team every time they take back dirty baskets. In this case, if the customer or his manager is not here, no complaint will be accepted. Every missing or broken article will be charged, 4€ per glass and 31€ per missing basket.

UNAVOIDABLE CIRCUMSTANCES

APS Location shouldn't be held responsible for delayed or canceled deliveries because of unavoidable circumstances (clutterings in the alleys, official restrictions, accidents...). No compensation will be granted.

LITIGATION


